### Additional Information

1. **Any office visit charges, examination fees, additional charges for surgical complications or females in heat or pregnant, required vaccination costs, or any other veterinary services you request are your financial responsibility.**
2. Surgical requirements such as pet's minimum age, pregnant females, and females in heat vary by veterinary practice and are to be discussed at the time the surgery is scheduled. If the pet has recently had a litter, wait one – two months until no longer nursing before scheduling your appointment.

## FELINE (CAT) SPAY & NEUTER ASSISTANCE PROGRAM

The goal of the Spay & Neuter Assistance Program (SNAP) is to end pet overpopulation by reducing the number of homeless cats and kittens and to educate the public about the importance of spaying/neutering your pets.

Every year thousands of animals are euthanized because of overpopulation and this does not include feral cats or strays killed by cars, starvation, disease, and other wild animals. We are all too keenly aware of the tremendous and heartbreaking waste that takes place on a daily basis.

The SNAP program is based on seeing the number of homeless cats and kittens in our area decline, so we decided to make a difference by offering it to our Tuolumne County residents.

### SNAP...THE LOW COST SPAY & NEUTER PROGRAM HELD THE LAST WEEK OF EVERY MONTH AT A COST OF \$40.00 PER CAT!

**Qualification:** If your gross household income is at or below \$21,200, you qualify for SNAP. In order to qualify for assistance you must include a copy of the first page of your most recent tax return, a pay stub indicating how often you are paid, or other proof of household income along with your application to receive your SNAP voucher. No more than four vouchers per household, per year, may be used.

**Application Submission:** Mail your application, the required documents along with a **self-addressed, stamped envelope** to the Humane Society of Tuolumne County, Attn: SNAP Program, PO Box 830, Jamestown, CA 95327. Please ensure that you:

1. Complete Part I of your application including all of your pet's information and remember one application must be completed for each pet to be spayed or neutered.
2. Sign and date your application.
3. Include proof of household income.
4. Note: The SNAP program cannot be combined with any other rebates, certificates or offers.

**Review of Application:** We will review your application and contact you if we need additional information or if anything is missing. Please allow up to three weeks for us to process your application. If approved, we will notify you by sending the SNAP voucher to you in your self-addressed stamped envelope.

**Make Your Appointment** (Available Appointments are Limited): When you receive your SNAP voucher, call a participating veterinary clinic, as indicated on your voucher, and advise them that you have an approved SNAP voucher. The SNAP voucher serves as a certificate for the \$40.00 discounted program and is good for 90 days from the date of issue and as indicated in the expiration section. Extensions of expired applications will be made on a case by case basis.

It is your responsibility to abide by the veterinary clinic's guidelines and drop off and pick up your pet at the designated day and times. Veterinary clinics may refuse application if anyone other than the pet owner takes the pet to the clinic and you may be required to produce appropriate identification. You may take advantage of additional needs for your pet at the time of your appointment, but you will be responsible for those costs.
